<b>Sl. No.</b>	<b>The school is directed to ensure that :</b>
1	The number of sections of Bal-Vatika shall be restricted to 9 (Three sections each in Bal Vatika I, II & III respectively) and total number of section of the school shall be restricted to 28 from class I to X. The optimum number of the students shall be restricted to 40 in each section. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq ft dimension.
2	School website is functioning and selective mandatory disclosures are published. As per Board guidelines and circular no 09/2021 the school should have a functional website with all mandatory documents available on the Mandatory public disclosure link for easy access to the public on school website in compliance of Circular No : 09/2021 Date of (21 May 2021). School shall provide all mandatory disclosures with link in prescribed formats within 03 months and submit the compliance.
3	One CWSN toilets noticed without installing the side supports bar on both side of the toilet seat. Thus, School shall construct the CwSN toilets separately for boys and girls on each floor with sufficient space for easy movement of the wheelchair as well as handrail on both side of toilet seat (fixed and movable) and proper permanent signage (on the cubicle indicating the floor number) as per guidelines of the Board and norms of RPwD Act 2016 within 03 months and submit the compliance.

4	As per Review Committee school has registered and obtained the EPF number and start the EPF Facility for the staff. School shall continue the EPF facilities to its all staff members with other mandatory statutory provision of the government and submit the compliance within 03 months.
5	Ramp constructed for the access of upper floor from outside is very steep and unsafe for the students. School shall reconstruct the same with proper incline and ensure that Lift installed by the school is safe and all safety clearance has been obtained from the concerned authority and submit the compliance within 03 months..
6	Only plant specimen are allowed in the Biology lab, species specimen are banned. Some restricted specimen are seen in biology lab that should be removed from composite science lab. Sufficient number of microscopes are not noticed, the lab is under-stocked in Biology section. The school shall upgrade the lab in the light of SoP within 03 months and submit the compliance.
7	The school shall ensure the mandatory training of its teachers with CoE, Bengaluru within 03 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school shall renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted within the stipulated 3 months , the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
